issues. Financial stability is also a priority, ensuring that Marshall continues to serve the Western slope as an independent, community based hospital. Finally, a focus on improving the workplace to position Marshall as the best place to work translates to making it the best place to receive care.



## Volunteers

In 2020, 677 VOLUNTEER HOURS were served by 47 adult and 16 junior Marshall Volunteer Services members. They assisted in 29 areas, including the hospital, office locations, and outpatient clinical departments. Volunteers also provided service to our community and participated in employee wellness, and volunteer health coaches visited patients in their homes.

Dog teams, as part of Marshall's Animal Assisted Activities, made visits to the hospital and the Cameron Park campus to help employees decompress and provide emotional support.

Cancer Center drivers provided an invaluable service, giving 91 cancer patients 220 RIDES to and from appointments.



677 VOLUNTEER HOURS provided by adult and junior Marshall Volunteer Services members.



Marshall Medical Center awarded \$4,000 IN SCHOLARSHIPS to area high school graduates to assist them in pursuing careers in healthcare.

Cancer Center drivers provided **220 RIDES** to and from appointments.



Even with a short hiatus due to the COVID-19 pandemic, Marshall Auxiliary still provided 6,727 hours of service in FY 2020. Since outside vendors and fundraising events were not allowed, the total funds raised was less than in previous years. Nonetheless, the Auxiliary donated \$35,000 from Gift Shop sales to benefit construction of Marshall's new kitchen and cafeteria, due to open in the summer of 2022.

#### HOLIDAY GIVING

170 Thanksgiving food baskets were donated by Marshall employees and providers and given to families, distributed through the El Dorado County Office of Education, Marshall Community Care Network, CASA, El Dorado County Community Health Center, SHARE, Upper Room, and MJ's Project.

In addition, 80 families received Christmas gifts and provisions through the El Dorado County Community Health Center and The Center for Violence Free Relationships.

## **COVID-19 HIGHLIGHTS**

## Pandemic Timeline

#### **MARCH** 2020

 El Dorado County declares a public emergency in response to the coronavirus pandemic. Stay at home orders placed to contain possible spread. Marshall Medical Center cancels elective and non-emergent procedures, closes and consolidates healthcare services to preserve supplies.

#### **APRIL** 2020

 Marshall Medical Center and the El Dorado County Office of Emergency Services developed a detailed surge plan to expand inpatient capacity by 50% -100% and beyond,



- including medical professional support, equipment and supplies.
- Triage tent erected in front of the Emergency Department to screen potentially positive COVID-19 patients and isolate them from other patients. A drive-through triage/testing route is established.
- 24/7 Telephone Triage Line established to screen patient calls related to chronic conditions as well as COVID-19 questions and follow up.

 All open clinics screened patients and staff prior to entry for signs/ symptoms of COVID-19.



- Telephone and virtual visits implemented.
- Outreach to local senior housing and skilled nursing facilities conducted to provide onsite medical screening and support – the goal of which is to allow vulnerable senior populations to remain in place while still receiving necessary medical care.
- Marshall participates in homeless outreach and sheltering activities.
- Donations of supplies such as gloves, masks, gowns, alcohol wipes, face shields and food were received from individuals, businesses and restaurants.

#### **MAY** 2020

 Because of the success of our county's shelter-inplace measures, El Dorado County



did not experience the rate of infections nor the patient surge we feared. Marshall began to reopen services with heightened infection control measures.



#### **JUNE** 2020

- Marshall continued to develop options for potential future waves by adjusting policies and processes. Financial losses due to low patient volumes and increases in pandemic preparedness expenses mounted.
- All Californians now required to wear face coverings in public spaces.

#### **JULY** 2020

 Marshall continued to prepare for a possible resurgence of coronavirus infections. We felt much more prepared with rapid testing and a more ready supply of sanitation resources and PPE.

#### **AUGUST/SEPTEMBER** 2020

• Schools don't reopen, many employees continued to work remotely.

#### **OCTOBER** 2020

 COVID cases rose in surrounding areas and in El Dorado County. Marshall braced for impact.

## COVID-19 HIGHLIGHTS

#### **NOVEMBER** 2020

- The western county begins to see an influx of COVID-positive patients. The COVID incident command team activated daily meetings to guide the organization through challenges.
- Marshall was able to keep most services open, balancing the needs of outpatient services with the emergent needs of the ED and ICU. Surgeries continued, but were reserved for urgent or emergent cases.

#### **DECEMBER** 2020

Lab volume increased dramatically. Marshall opened a drive-through COVID testing site at the



- hospital and a drive-through respiratory clinic in Cameron Park was established. where patients were tested and treated in the comfort and convenience of their own vehicles.
- The end of December saw a sharp rise in COVID cases. There was an outbreak of coronavirus in all of the area senior living facilities. Marshall doctors went into action, making rounds at the senior facilities to care for residents, hoping to keep them

- from developing complications requiring admission to the hospital.
- Marshall Hospital experienced our highest COVID patient census. Employee exposures were also increasing, affecting staffing to the point of crisis. Many people worked long hours and picked up extra shifts to make sure our patients were covered.



- In late December, Marshall received the much-anticipated COVID-19 vaccines and by Dec. 29, 1,094 health care workers and volunteers were vaccinated. Marshall mobilized teams to vaccinate nearly 400
  - residents and staff in area senior living facilities.
- Marshall sponsored drive-through vaccination clinics in

## Spotlight on Safety

While patient and staff safety has always been a priority at Marshall Medical Center, it was of critical significance during the COVID-19 pandemic. Implementing strict health screening protocols for anyone entering Marshall's facilities, quickly training staff on evolving PPE usage guidelines,


daily screening staff for COVID-19 and keeping the hospital and clinics clean and safe were just a few areas of focus. A supplementary investment was the acquisition of **four additional Xenex Lightstrike robots**, ensuring the highest level of disinfection.



Marshall received national recognition for its commitment to health and safety from the Leapfrog Group, who gave Marshall an "A" in the Fall 2020 Hospital Safety Grade program.

Marshall was top among 2,600 hospitals for demonstrating "a continued commitment to patient safety and the reduction of avoidable harm." In addition, The California Department of Public Health (CDPH) recognized Marshall with a bronze designation as a top performer in its Healthcare-Associated Infections Program. Marshall's participation in the CDPH antimicrobial stewardship program is part of the hospital's dedication to improving patient outcomes while monitoring the use of antibiotics.

Marshall is also part of the **inaugural group of BETA Healthcare Group members** to participate in the Employee Safety & Wellness Initiative, tackling common trends in employee safety with the goal of helping to reduce employee injuries.

When the pandemic hit, Marshall saw a need to help find services for the county's most vulnerable. The effort dovetailed with Governor Gavin Newsom's Project Roomkey, an executive order mandating hotels be made available as temporary residences to quarantine and treat individuals who have tested positive for COVID-19. In partnership with area nonprofit organizations and public agencies, the Navigation Program in El Dorado County was born to address the needs of the homeless community, including medical, housing, obtaining state identification and proof of citizenship, food stamps and cell phones.

In a related effort, Marshall established the Multi-Visit Patient Program to address the homeless' chronic medical needs in an effort to reduce the use of the Emergency Department for primary care.


Though CARES set out primarily treating opiate use

disorder, it has grown into a clinic focused on helping people who use any drugs, including alcohol.

The Emergency Department sees patients 24-7/365 with an open door to treatment for substance use disorders. The department focuses on treating opioid use disorder and providing life-saving treatment from drug withdrawal and post-overdose using buprenorphine. For two years, Marshall has received the Cal Compare award for this work, and is recognized as a Center of Excellence by CA Bridge and awarded with grant funding to continue this innovative and nationally recognized work.

#### Community Care Network

Marshall's Community Care Network (CCN) assists patients with chronic illness as they navigate through the medical system and helps optimize their quality of life. Over the past year, 3,026 patients have been supported by the CCN team, which includes a pharmacist, social worker, nurses, physical therapy aid, dietitian, and resource specialist. Through generous donations arranged through the Marshall Foundation for Community Health, CCN has provided blood pressure cuffs, scales, food and equipment for patients who were in need.





#### Transitional Care Center Closure

After 30 years, Marshall's Transitional Care Center (TCC) closed on August 1. Due to changes in the regulatory environment, this model of care became unsustainable for Marshall. This decision was made thoughtfully and in consideration of our patients, providers and staff. Marshall continues to work with area skilled nursing facilities, ensuring an excellent continuum of care.

- **Marshall Medical Center Education Department** received funds for The Daisy Program which recognizes the clinical skill and especially the compassion nurses provide to patients and families all year long.
- The Collegiality Event Fund via Marshall Medical Center Providers was granted funds to assist with the opportunity for providers to meet and share meals to discuss topics relevant to their experience.
- Marshall Medical Center Emergency **Department** was given funds to purchase a Stryker Lucas 3 Automated CPR Machine. This machine delivers high-performance, continuous chest compressions with less strain, micromanagement, and risk for the caregiver.
- Marshall Medical Center received a donation to create a Stillness Room. Healthcare jobs are considered some of the most stressful careers in the country, and 2020 has been no exception. The Foundation provided for a staff decompression room to give hospital employees a quiet space to take a break and regroup their thoughts. Their mental, emotional health is of utmost importance for patient care.

- Marshall Medical Center Birth Center received a grant for "Baby Friendly" designation and certification by the World Health Organization and UNICEF, showing that the Marshall Birth Center meets the highest standards for mother/ baby care practices related to infant feeding.
- National Night Out was granted to fund programs to create awareness about tobacco and alcohol abuse. The programs are held in Camino and Placerville.
- Mathewson-Bonser Nursing Scholarships were granted to Marshall Medical Center nurses for their continuing education.
- **Strength for the Journey** received funds for support groups and professional counseling for those who have experienced sudden loss.
- Marshall Medical Center and Community Health Restricted Funds were provided donations that the Marshall Foundation for Community Health fiscally oversees.

Marshall's priority continues to be the health and wellbeing of the residents of El Dorado County, providing care for all those who come through our doors.



#### **Bond Sale**

In late April, Marshall issued \$75M in bonds, allowing us to invest in growth opportunities and other projects. The funds generated by issuing the bonds will be used to fund major projects such as the construction of the cardiac catheterization lab and the new kitchen and cafeteria. It was also used for the purchase of an upgraded MRI machine and a building and land for Cardiac Rehabilitation services and staff parking.

#### Construction & Expansions

The Diagnostic Imaging Department located at Marshall Hospital was remodeled to include the construction of a permanent MRI suite, the expansion of ultrasound services to include interventional services, and doubling the nuclear medicine space. The design incorporates a separate access area for mammography and breast ultrasound to create a more private approach to women's imaging services.

#### Direct Line from PG&F

In order to ensure constant power to Marshall Hospital in the event of a Public Safety Power Shutoff (PSPS), Marshall's electric system was tied into the PG&E back up system. This means Marshall Hospital and most of the outpatient clinics surrounding it are on the same grid that PG&E keeps running with several generators When a PSPS occurs, a seamless transition to generator power will occur so as not to disrupt patient care.

#### PROJECTS IN PROCESS:

#### Cafeteria and Kitchen Project

Work continues on construction for a new hospital kitchen and cafeteria, as well as the creation of an outdoor seating area. Completion is expected at the end of 2021, with an opening anticipated in mid 2022.

#### South Wing CT Scanner Replacement

Plans are in development to replace the Computerized Tomography (CT) scanner in the south wing of the hospital. The scanner provides essential services to Emergency Department patients and compliments the CT scanner in Radiology. This CT scanner will incorporate a scan table that has a 700 lb weight limit to accommodate bariatric patients.

#### Cardiac Rehabilitation Services

Plans are in progress for the remodel of a recently acquired building at 1000 Fowler Way. Patients will be able to choose between traditional or Pritikin's Intensive Cardiac Rehab which will include additional sessions of education and training. It will be home to a spacious exercise rehabilitation gym and a separate educational multipurpose room.
